All document-related interactions are recorded in a secure audit trail to ensure a strong body of evidence in case of litigation. Accessible only to dedicated administrators, the audit trail includes all user history and transaction details without disclosing personally identifiable data.

Integrated with DSaaS

Entrust DSaaS is a cloud service designed to issue identity-verified digital certificates for employees and to securely store them in the Entrust cloud. This “as-a-service” approach removes the burden of hardware management required with traditional digital signatures in USB tokens.

Entrust is a Qualified European Trust Service Provider and a member of the Adobe Approved Trust List (AATL). All our digital certificates for document signing and sealing are natively trusted by Adobe Reader and Adobe Acrobat.

No personal data or document is sent by Let's Sign to Entrust DSaaS, only hashes.
